

Combined test dressage: Elem: USEA Starter A , Intro: USEA Starter A, Starter: USEA Starter A; BN: USEF BN A, Nov: USEF Nov A, Training: USEF Training A, Prelim: USEF Prelim A

Entries: Combined test, one ride per class. Ribbons 1st-6th.

Time schedule: Dressage starts at 8:30 am, Elem, Intro, Starter, BN, Nov, Training, Prelim in that order.

EXTRA jump round at end of class. Must preregister. \$10

All riders must wear, at a minimum; ASTM/SEI approved helmets/boots. A negative coggins is required for all horses within the last 12 months.

Dogs discouraged or always leashed. No exceptions.

Closing date is Wednesday March 25th or 50 entries, whichever comes first.
