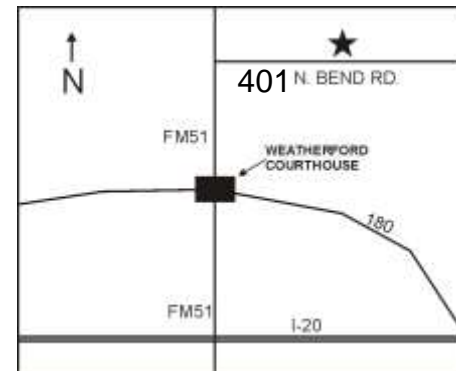

Entries: Combined test, one ride per class. Ribbons 1<sup>st</sup>-6<sup>th</sup>.

Time schedule: Dressage starts at 9 am, Elem, Starter, BN, Nov, Training, Prelim in that order.

EXTRA jump round at end of class. Must preregister. \$5

All riders must wear, at a minimum; ASTM/SEI approved helmets/boots. A negative coggins is required for all horses within the last 12 months.
