

All riders must wear, at a minimum; ASTM/SEI approved helmets and boots. A negative coggins is required for all horses within the last 12 months.

Dogs discouraged or leased at all times. No exceptions.

Ribbons 1st-6th. Classes with 3 or less, no ribbons.

No phone or email entries accepted. No outside shavings. Extra shavings \$10. Clean stalls of hay, manure, wet spots, do not strip. Dirty stalls not invited back.
